Chairman Smith called the meeting to order at 7:32pm.

Town Hall Update:

<u>Front Door Replacement Update:</u> Donna Rich reported that the front door had been in installed and the cost came in \$3,800 over the quote. There was \$1,000 that was put in the budget as contingency and was used toward the door, in addition a Warrant Article for Town Building Repairs was utilized for the remaining \$2,800. The committee discussed the top arch and glass. It was advised to obtain a quote for the repairs to this area.

<u>Project Budget Final Update</u>: Donna Rich reported that the remaining balance of \$43,564.63 for the project has been expended, in its entirety.

Recognition Plaques Update: The plaques for the commissioned Meg Black painting and the Gilbert Steward plaque size were reviewed. It was decided that the size should be 8 ½ X 5 ½ inches. Placement was discussed.

<u>Recognition Bench Update</u>: Donna Rich reported that Norm Isler, Historical Society, had purchased the bench in memory of Mark Lyons. There will be a plaque on the bench. The placement would be beside Joel Ulchenick's memorial bench, in front of Town Hall.

<u>Door to Roof Update</u>: Donna Rich explained that Consigli Construction had placed weather stripping on the door that leads to the roof, which was allowing water to come into the building.

<u>Meeting Schedule</u>: The members agreed to the schedule as presented.

<u>Minutes</u>: Ben Nutter made a motion to approve the minutes of November 6, 2019; seconded by Josh Rownd, so voted: 3-0.

<u>Friends of The Town Hall:</u> Al Wallace distributed a quote for a stage curtain. The members discussed bringing in an advisor, Steve Hall, to assist with a decision on this item. Josh Rownd volunteered to discuss the opportunity with Steve Hall.

The members discussed identifying a list of items the Friends could raise money for:

- 1) Theatrical Stage Curtain for the Public Hall
- 2) Seating for the mezzanine area
- 3) Picture rail for area around Town Hall, hallways, conference rooms, etc.
