MINUTES OF MEETING October 2, 2020

Call to Order: A regular meeting of the Board of Assessors was held remotely via conference call on Friday, October 2, 2020. Assessor Report: The residential sales analysis has been completed. We are in a good place with the residential homes. Some adjustments to Rolling Green and the Great Hill Coop. The commercial valuations will be done by Wayne Peterson of Patriot Properties next week.

New growth number in revenue should be around the \$200,000 figures due to the completion and sales of Rolling Green and a few of the newer homes built in 2019. We will be working on the recap next. The Board was reminded that they will have to sign into Gateway and sign off on some of the DOR forms, such as the LA-4 and LA-13.

New Business: There was discussion of the Perkins Row development. The lots have been split and will be picked up for new growth next fiscal year. One of the parcels has just sold.
