# Minutes of Monday, April 23, 2018 7:30 PM

Board Members present were Chairman Boyd Jackson, Clerk Mark Lyons and Selectmen Richard Gandt and John Spencer. Laura Powers was not in attendance. Of the Selectman's Staff, Town Administrator Kellie Hebert and Executive Assistant/ Recording Secretary Debi Morong were in attendance.

#### **CALL TO ORDER**

Chairman Boyd Jackson called the meeting to order at 7:31 PM.

The Board stood for the Pledge of Allegiance and then observed a moment of silence.

# Departmental Update

Housing Authority: Dick Cullinan

The Topsfield Housing Authority is an elected and appointed Board charged with managing state housing located in town under the terms as directed by Mass Department of Housing and Community Development.

Little Brook Village located at 69 Washington Street Topsfield underwent a 1.5 million dollar renovation project in 2017. The Department of Housing and Community Development (DHCD) awarded a grant of \$478,000 for ADA Compliancy upgrades. These are the updates/repairs that were made:

- > Removed and replaced all rotted window sills in all units
- > Painted all first floor units
- > Tiled floors in all the first floor units
- Repaved all walkways to ADA standards
- > Built ramps to ADA Standards
- Handicapped parking spaces added
- > Car safety barriers in place
- > Rear Emergency Handicapped Access
- > Re-planted trees that were removed during renovations

Received an additional \$340,000 grant from DHCD to:

Replace Fire Alarm Systems in all buildings

The last phase of the building repairs will be to paint all five buildings and repair the outside trim. This part of the renovation project may take time to get grant funding due to the many requests from the various state housing programs. The Topsfield Housing Authority does not receive any funding from the town.

#### **NEW BUSINESS**

### Donibristle Farm LAND Grant

The Donibristle Farm project has been awarded a local Acquisition for Natural Diversity (LAND) Grant from the state and the Conservation Restriction (CR), the CR assignment and the Purchase and Sale Agreement now include language

acknowledging the LAND Grant award, the Purchase and Sale Amendment also revises section 2 and 6 of the original Purchase and Sale which has been reviewed by Town Counsel. Funding was outlined in Article Thirty-Sixth as voted at Town Meeting held on May 2, 2017.

- Selectman Gandt made a motion to accept the terms of and to execute, the First Amendment to Purchase and Sale Agreement, amending the Purchase and Sale Agreement dated July 24, 2017 related to the acquisition of the Donibristle Farm Conservation Restrictions; and
- 2. To acquire the partial assignment and assumption of the Conservation Restriction recorded at the Essex South Registry of Deeds in Book 36243, Page 443, for the 1.825 acre Hill Street parcel, to be held under the care, custody and control of the Conservation Commission under the provisions of G.L. c. 40, s. 8C and to execute any and all documents as may be necessary or appropriate therefor in the best interest of the town; and
- 3. To acquire a Conservation Restriction on approximately 43.57 acres of land off of Rowley Bridge Road from the Essex County Greenbelt Association, Inc. to be held under the care, custody and control of the Conservation Commission under the provisions of G.L. c.40, s. 8C and to execute any and all documents or instruments as may be necessary or appropriate therefor in the best interest of the town.

Selectman Spencer seconded the motion and they were approved with a vote of 4-0.

# Public Way Access - Approval of Routes

Selectman Gandt made a motion to approve the request from the Bourque Family Foundation for a 7.7k benefit road race on Saturday, June 9, 2018 and will be accessing some of Topsfield's roadways from approximately 4PM until 6PM. Selectman Spencer seconded the motion and it was approved with a vote of 4-0.

# Water Department Budget

- Water Treatment Plant will come up in fiscal year 2019 (April 2019) and is reflected in the budget.
- The FY19 water rates will increase approximately 29% due primarily to the cost of the Water Treatment Plant.
- > Bids for Water Treatment Plant were considerably higher than anticipated
- Plant is being built a year earlier than anticipated; but the town is saving approximately 3%
- 6 months to a year before the Water Treatment Plant can go to automated operations; staffed 24/7 until DEP approval
- River Road project is included in the cost of the Water Treatment Plant

Selectman Gandt made a motion to approve the Water Department Budget for FY2019 for \$1,771,901 as submitted. Chairman Jackson seconded the motion and it was approved with a vote of 4-0.

## Water Main Improvement Project: Award of Contract

Prospect Street and River Road have had numerous water main breaks over the past 10 years. The sum of 1.6 million was appropriated at the 2017 Annual Town Meeting for replacement of the water mains on these roads. The design and permitting were finalized in 2017, but bidding was delayed until this year due to borrowing restrictions. The total project cost is estimated to be 1.3 million.

Chairman Jackson made a motion to approve a contract for the Prospect Street and River Road Water Main Improvement Project to R+D Development of Groveland, MA for a price not to exceed \$968,540.89. Selectman Spencer seconded the motion and it was approved with a vote of 4-0.

# Kinsmen Corporation Change Order Request

This change order is for the purchase and installation of a harmonics filter for the booster pump station being constructed at the Public Works Facility. The station will provide fire protection for the Water Treatment Plant and has the capacity to protect the existing Public Works building. The harmonics filter is needed to reduce electronic disturbances caused by the variable frequency drive for the 100-horsepower fire pump. The pump station designer included a device to migrate the disturbances, but calculations made by the engineer and verified by the owner's project manager indicate a higher level of protection is required. The funding for this contract is from Article Third approved at the 2017 Special Town Meeting held on June 20, 2017.

Selectman Gandt made a motion to approve the change order request #1 with Kinsmen Corporation of Hookset, NH for an amount not to exceed \$9,316 for the Water Treatment Plant project. Selectman Spencer seconded the motion and was approved with a vote of 4-0.

# Consigli Change Order Request

At the May 3, 2016 Annual Town Meeting and with the passage at the Ballot on May 5, 2016, the Town Hall Building Project funding was approved for design and construction of the Town Hall Preservation, Renovation and Expansion.

Selectman Spencer made a motion to approve change order #6 with Consigli Construction for an amount not to exceed \$172,182.66 for the Town Hall Preservation, Renovation and Expansion Project. Selectman Gandt seconded the motion and it was approved with a vote of 4-0.

## Professional Services Amendment

The proposed Professional Services Amendment #6 from McGinley, Kalsow & Associates, Inc. in the amount of \$11,330 addresses extra fees for a portable generator, the change of a storage area into a private office space, a catwalk in the attic and lifeline cable. The Amendment will be funded within the existing project contingency budget.

Chairman Jackson made a motion to approve the Professional Services Amendment #6 from McGinley, Kalsow & Associates, Inc. for an amount not to exceed \$11,330. Clerk Lyons seconded the motion and it was approved with a vote of 4-0.

## Records Management System

Annual Town Meeting Warrant Article Twenty-Third will ask the Town to vote to raise and assess funds to purchase technical and professional information management services to implement a comprehensive records management system for the records of the Land Use Departments. The project includes the creation of a public records inventory, document management system, records database and record retention and disposal.

King Information System, Inc. is an indexed filing system for maps and plans. The Trackslider Systems are movable files that hold documentation in half the floor space that stationary files require.

# <u>Update on Potential Host Community Agreement (HCA)</u>

The act requires that both recreational marijuana establishments and medical marijuana treatment centers enter into a HCA with host communities and allows for a community impact fee.

- > The community impact fee must be reasonably related to the costs imposed upon the municipality by the operation of the marijuana establishment of medical marijuana treatment center
- > The community impact fee shall not amount to more than 3% of the gross sales
- > HCA should not be effective for longer than 5 years
- > The municipality is required to document its costs
- Applicant must certify to the Cannabis Control Commission (CCC) that it has entered into a HCA as part of its application process

Selectman Spencer met with Bob Patton, CEO Green Meadows Farm to discuss a potential HCA between the Town of Topsfield and Green Meadows Farm. Some of the items discussed:

- > Cultivation and processing of Medical Marijuana only
- No marijuana use on site
- Green Meadows will adhere to all state and local regulations, guidelines & bylaws
- > Agree to use of local business services and products when possible
- > The Town will have the right to approve the on-site General Manger
- Maintain regular communications with Topsfield Emergency Services
- > Green Meadows will pay real estate taxes based upon commercial value
- > Annual payment to the town of 1.25% based on gross sales
- > HCA shall be for 5 years; with an annual review
- Any changes to ownership or operations management, the Board may withdraw their letter of support and declare the HCA null and void
- Any new or revised HCA negotiated by the Town and Green Meadows will not assume continuation of any terms in a previous agreement.

Memoranda of Agreement between the AFSCME Water/Highway and the Town of Topsfield & AFSCME Parks and Cemeteries Units and the Town of Topsfield Town Administrator Kellie Hebert gave the Board an update on the Town's negotiations with the Topsfield AFSCME UNITS.

# Negotiations for MOA:

- > 2% cola for each year of 3 year contract (Retro for FY2018)
- > 25 cent increase for each employee's base pay retro to January 1, 2018
- > 25 cent increase for each employee's base pay in 3rd year of contract (FY2020)
- Bi-weekly pay and Electronic Deposit implemented

Selectman Gandt made a motion to approve the MOA between the Town of Topsfield and the AFSCME Water/Highway Unit (FY2018-FY2020). Selectman Spencer seconded the motion and it was approved with a vote of 4-0.

Selectman Gandt made a motion to approve the MOA between the Town of Topsfield and the AFSCME Parks and Cemeteries Unit (FY2018-FY2020). Selectman Spencer seconded the motion and it was approved with a vote of 4-0.
