BOARD OF SELECTMEN Working Session Town Hall Conference Room Minutes of May 21, 2015

Chairman Powers called the meeting to order at 4:05PM. Board members present in addition to Chairman Powers, were Martha Morrison, Boyd Jackson, Laura Powers, Steve Lais and Eldon Goodhue. Of the Selectmen's staff, Town Administrator Kellie Hebert was in attendance. Other persons present during some or part of the meeting were Fire Chief Ron Giovannacci and Fire Captain Jen Collins Brown.

<u>Memorial Day Parade</u>: Selectmen Morrison made a motion to approve a Memorial Day Parade to be held on May 25th beginning at 9AM with a route to proceed down Main Street to the Veterans Green for a ceremony, seconded by Selectman Goodhue; so voted: 5-0.

<u>24/7 Fire Service</u>: Chairman Powers opened up the discussion for the membership criteria of the seven member committee. Selectman Lais expressed his opinion that the members should be objective and Selectman Jackson concurred that the members should have no previous stated opinion of the mission of the committee. Selectman Goodhue added that the previously formed fluoride committee was a good model to follow, explaining that the members appeared to be good thinkers and that would be an asset to this committee. The Board concluded that each member should develop a "pool" of names and the Board would then review the list of names at a Working Session on June 1st at 4:30PM. Ms. Hebert offered an example of a charter that was used for a similar committee in the Town of Tyngsborough expressing that it could be used as the start of a charter document. Selectman Jackson described some ideas that he felt should be incorporated into the charter.

At 4:47 PM, Selectmen Lais made a motion to adjourn and Selectman Goodhue seconded the motion; so voted: 5-0.
