Cheryl Jolley, Chairperson, called the meeting to order, by video/audio conference, at 7:02 p.m. with a quorum present. She made the following announcement:

"Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitations on the number of people that may gather in one place, this public hearing of the Topsfield Conservation Commission is being conducted via remote participation. No in-person attendance of members of the public will be permitted, but the public can listen to and/or view this meeting while in progress by joining the Zoom Meeting at the link listed on the posted agenda or by calling 1-929-205-6099 and entering meeting ID and password listed on the agenda. Members of the public attending this meeting virtually will be allowed to make comments if they wish to do so, during the portion of the hearing designated for public comment as announced by the chair during the hearing."

Chairperson Jolley announced that the meeting was being recorded by the Zoom videoconference. Attendance was taken by roll call.

Jolley read the following announcement:

A RDNI application was submitted to remove one dead tree at 3 Surrey Lane. Gaffney displayed photos of the dead tree with a split trunk. She confirmed with the Topsfield tree warden that the tree was not on town property and recommended approval of the tree removal.

ADMINISTRATOR'S REPORT

Gaffney reviewed the following:

- The process to implement the use of electronic signatures is underway, as voted at the May 27, 2020 meeting. Signature pages will continue to be distributed for original signatures for the file.

OTHER

• Enforcement Order 2020-01: 71 Howlett Street (Map 33, Lot 19)

Gaffney provided an update on EO 2020-01 71 Howlett Street. The homeowner has hired Hancock Associates to work on compliance with the Enforcement Order. Hancock Associates has submitted an extension request for the submittal of an existing conditions plan and a restoration plan to the July 15, 2020 meeting. Gaffney recommended that the extension be granted.

Luther moved to grant the request for an extension for the submittal of an existing conditions plan and a restoration plan to July 15, 2020 to comply with the Enforcement Order. Shamroth seconded the motion and it was approved by roll call vote:

• Enforcement Order 2020-02: 46 Cross Street (Map 62, Lot 23), Ginley – update

Gaffney provided an overview of activity related to EO 2020-02. A request was received from the property owner for the waiver of an existing conditions survey plan required as part of the EO. Gaffney displayed photos of the disturbed area of which several trees and all understory was removed with soil disturbance up to the wetlands and on to neighboring properties. Bill Manuell, Wetlands & Land Management, Inc. has been hired to work with the property owner to comply with the EO. Erosion control has been installed.

The property owner, Dan Ginley, informed the TCC that he requested the waiver of the existing conditions survey plan because he is currently unemployed due to the COVID-19 shutdown and finances are an issue. He stated he did the work on his property to get rid of dead wood. He discussed his interactions with his neighbors regarding the EO.

Discussion was held on the requirement for the existing conditions survey and how to communicate with and address the involvement of neighbors where it appears from the town assessor's GIS that work may have occurred off property. She commented that the existing conditions plan would have been due in two weeks, at the June 10, 2020 meeting. A delay in completing a survey plan is expected because of a current backlog for surveys.

Luther moved to extend the enforcement process until June 10, 2020 for the specific purpose of hearing from Bill Manuell, Wetlands & Land Management, Inc. as to the extent of the damage, the existing conditions survey plan and the remediation plan. Shamroth seconded the motion and it was approved by roll call vote:

• Enforcement Order 2020-03: 65 Rowley Bridge Road (Map 55, Lot 3), Dunn

The property owner, John Dunn, provided information on the work done that resulted in the enforcement order. Bill Manuell, Wetlands & Land Management, Inc. has been hired to work with Dunn on compliance with the EO. Manuell will attend the June 10, 2020 meeting.

Violations: Gaffney provided information on the following violations:

- 9 Coventry Lane The Certification of Compliance plan has a designated "No Disturb" area. The property owner, Hadley Coonley, commented that they were unaware of the No Disturb area and described the work they have done. Bill Manuell, Wetlands & Land Management, Inc., has been hired by the property owner and an after-the-fact Notice of Intent will be submitted
- 14 Sleepy Hollow The new property owners were not aware of the jurisdictional areas on the property and have dumped bricks into the wetland and cut a tree down. Gaffney will visit the site.
- 18 Candlewood Gaffney will provide an update at the June 10, 2020 meeting.
- Bylaw Fee Schedule Revisions tabled
- Proposed Bylaw Regulations Revisions tabled
