# Topsfield Conservation Commission Minutes of Meeting June 24, 2020

Cheryl Jolley, Chairperson, called the meeting to order, by video/audio conference, at 7:02 p.m. with a quorum present. She made the following announcement:

Gaffney displayed the as-built plan for the project completed under 2003 Order of Conditions 307-0436 for the construction of the driveway, retaining walls, grading, utilities and appurtenances related to the construction of the house at 70 Alderbrook Drive. Gaffney visited the site on June 23, 2020 and has received the engineer's letter confirming that the construction complied with the order. A dry well was not installed as no gutters were installed on the house and the roof runoff falls to a stone drip edge around the house. Gaffney recommended that a Certificate of Compliance be issued.

Luther moved to approve the Certificate of Compliance for 307-0436, 70 Alderbrook Drive, for work substantially conducted in accordance with the Order of Conditions. Shamroth seconded the motion and it was approved by roll call vote:

Gaffney recommended issuing a Certificate of Compliance.
