Topsfield Conservation Commission Minutes of Meeting November 4, 2020 By Video/audio conference

Cheryl Jolley, Chairperson, called the meeting to order, by video/audio conference, at 7:04 p.m. with a quorum present. She made the following announcements:

"Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitations on the number of people that may gather in one place, this public hearing of the Topsfield Conservation Commission is being conducted via remote participation. No in-person attendance of members of the public will be permitted, but the public can listen to and/or view this meeting while in progress by joining the Zoom Meeting at the link listed on the posted agenda or by calling 1-929-205-6099 and entering meeting ID and password listed on the agenda. Members of the public attending this meeting virtually will be allowed to make comments if they wish to do so, during the portion of the hearing designated for public comment as announced by the chair during the hearing."

"The meeting is being recorded by BCTV via ZOOM to be posted on the Town Website for public viewing; is there anyone else present who wishes to record the meeting?" There were no responses.

Representing the applicant, Elizabeth Wallis, Hayes Engineering, Inc., presented information on the proposal to replace a failing cesspool with a septic tank and leach field. The property is a single family home. The leach field is proposed to be located behind the house within a grassy area. The area is within 100 feet of flagged BVW and within the 200 foot Riverfront Area. Wallis provided details on the excavation and grading. The area will be loamed and seeded after installation. No trees will be removed. Discussion was held on alternative locations for the system.

Gaffney displayed aerial views and photos of the property and provided her comments. Gaffney agreed with the placement of flags 11 and 12. However, the Riverfront area could not be accurately delineated as it is off of the subject property. Gaffney recommended that the as-built plan submitted to the Health Department be noted that the Wetland and Riverfront delineations are not confirmed. A copy should be provided to the Conservation Office.
