Next concert featuring Topsfield musicians (Mulefoot) will be on August 25th. Flyers will be posted. Need to recruit a volunteer to take over concert committee. Lynne Bermudez suggested advertising on library e-mail. At the end of meeting, COA Member, Kimberly Love, volunteered.

- -trip to Marshfield Fair (weather permitting), Aug. 20th, backup plan, dine at restaurant participating in Dine Out Boston promotion.
- -Senior Scoop" will advertise Hamilton COA Trips, which are open to Topsfield residents.
