DIRECTOR'S REPORT:

- TRIAD had 50 persons signed up of the workshop on decluttering with the free lunch. Recycle bins will be put at the DPW station on Rt.1 for the Recycle Day on May 14th. Farmer's Insurance in town sponsored the luncheon.
- AARP tax help is over for the season.

- The Friends of the COA may have to disband. Presently there is no President and no Vice President. There have been health issues plaguing members of the Friends. A lot of work falling on a rew. It is difficult for people to have a sense of where the money is going when it is contributed to the Friends.
