## 9 Perkins Circle Variance Requests

Thomas Mannetta CE from Thomas Mannetta Inc., representing the 2014 Gibbons Family Trust, presented the three Variance Requests outlined on the Form 9A Application for Local Upgrade for 9 Perkins Circle.

- Reduction in separation from a leaching field and to the property line 7 feet is proposed
- Reduction in separation from the combination tank to the property line 7 feet is proposed
- Use of only one deep hole in proposed disposal area

Mr. Mannetta gave the Board a description of the limitations of the property necessitating the requests. Board Members discussed the request.

VOTE: Mr. Rizza made a motion to approve the Variance Requests as outlined in the Form 9A Application for Local Upgrade Approval received at the Board of Health on August 23, 2021. Seconded by Ms. Eaton. After determining that there was no further discussion, Chair Knutsen called for a roll-call vote:

The motion carried in a vote of 4-0.
