OPENING

The meeting of the Topsfield Board of Health was called to order at 6:01 pm on March 15, 2023 by Chair Sheryl Knutsen.

ANNOUNCEMENTS

Chair Knutsen made the following announcements:

Pursuant to Chapter 20 of the Acts of 2021, this meeting/public hearing will be conducted via remote means. Members of the public who wish to access the meeting may do so in the following manner: Zoom Meeting – see connection information below to join the meeting by Zoom videoconference or calling in by phone. NEW BUSINESS

15 Perkins Circle - Request for Reclassification of Bedroom Count

With no homeowner or representative in attendance, Health Director McDonald presented the request for a reclassification of bedroom count at 15 Perkins Circle from 4 bedrooms to 5 bedrooms as follows:

- Email dated March 7, 2023 from Chad Stutz requesting a reclassification of 15 Perkins Circle from a four bedroom dwelling to a five bedroom dwelling because the septic system has now been upgraded to accommodate 5 bedrooms.
- Copy of Septic As Built Plan accepted by Health Director Gerard McDonald on March 14, 2023 indicating a 5 bedroom system.
- Mr. McDonald noted that there is a Title 5 Bedroom Count Deed Restriction on the property dated February 12, 2012 for four bedrooms.
- The Board determined that the Deed Restriction could be amended if requested to indicate five bedrooms.
- The Board determined that in the future, applicants for this type of request must be present or have a representative present for the meeting. The Criteria for Requesting a Reclassification of Bedroom Count under Title 5 will be reviewed at the April 19, 2023 meeting.

The Board determined that the request met the criteria to grant a reclassification.

HEALTH DIRECTOR REPORT:

The Board welcomed new Health Director Gerry McDonald.

<u>Director McDonald presented the following report to the Board:</u>

Housing:

Amberwood Mouse Complaint- Tri-Town Health Inspector Mark Carleo attempted to conduct an inspection on multiple occasions and no-one answered the door. On February 24, 2023, a letter was sent to the owner of the unit in question with a request to contact the Board of Health with copies to the property manager and president of the homeowner's association.

Mr. Carleo has resigned as Tri-Town Inspector, effective date 3/6/2023. He has returned materials provided to him to Topsfield Health Department office. Middleton Health Agent in process of setting up interviews to fill position and coordinating with Topsfield and Boxford.

John Coulon RS hosted Gerry McDonald on a tour of the Topsfield Fairgrounds, the Nike site, Alfalfa and Connemara Farms. Introduced Gerry to Jamie O'Brien at the Fairgrounds.

68 River Road – on hold pending application for demolition. Heidi Gaffney has been conducting site visits with reps from DEP re: dewatering basement which continues to flood. Application received for soil testing.

13 Ross Road – At January 25, 2023 Meeting, the Board voted to allow the resumption of human habitation. Mr. Wilson and his wife are back home.

Barry Keppard from MAPC has been assisting with PHE Grant Deliverables. Sheryl Knutsen has been attending ARPA meetings.

Other:

Thank you to Chair Knutsen for stepping into the lead role in the office and to Mark Rizza for his help with the FY24 Budget process.

Gerry McDonald has accepted position of Health Director and has been working in that role since March 1, 2023.

Title 5 Inspection Reports, Food Permit Renewals, Septic Installer and Hauler Renewals, Septic Reviews, Certificates of Compliance issued, projects moving forward.

Tri-Town Public Health Nurse Julia Lobel RN presented the following report to the Board:

Topsfield BOH Meeting March 15, 2023

COVID:

Trending down on wastewater area plants

Tri-town vaccination clinics have been successful, each clinic serves ages 6 months and up clinics will continue to run through June 2023

March 16th Topsfield Town Hall

March 23rd Middleton Flint Library

May add Boxford COA once new space is open and I have office space there, anticipated date pushed back to April 15th. Will have regular hours there on Thursdays, date has kept getting moved because of construction delays. Kendall has previously stated there was no office space available at Town Hall/Health Dept. All individuals 6 months and up are now eligible for an updated bivalent booster vaccine. Clinics have been slowing down, the primary need is for infants completing or starting vaccine series. Less than 10 appointments per clinic right now. Pediatricians are not carrying vaccines due to storage and ordering minimums.

FLU UPDATE:

Estimated flu severity in low level in MA according to DPH

45.75% vaccination rate coverage

Will likely see second wave of flu B - some cases coming into MAVEN already

Flu vaccine continues to be offered at Topsfield Town Hall (from remaining Middleton supply) advertised on Town website to call health dept

iHealth Test Kits:

FDA extended expiration dates on iHealth test kits an additional 3 months in January (for a total of 9 months from original expiration date listed on the package) (Or 15 months from date of manufacture, which is not actually listed on package)

QR codes were finally updated

Majority of test kits circulating in Tri-Town all expire in April, some kits expire in June that Topsfield distributed Keep any leftovers in storage and wait to see if expiration dates will be extended, don't throw them away yet!

New COMBO FLU/COVID Test kits approved by FDA:

The U.S. Food & Drug Administration has authorized the first over-the-counter at-home test that will test for both the flu and COVID-19 viruses.

Test kits have been available in Canada Since August 2022

Price could be around \$70

Nasal swab, PCR test, 30 minutes for results

The company filed for bankruptcy so unknown timeline for when test kits will be made available If tests become readily available, they will be a game changer in early identification of disease, and hopefully reducing spread of disease.

There are some consequences to using at-home tests, IE people not getting proper treatment, not detecting variants, and false negatives from inaccurate testing too early.

Strep throat:

Increase of strep cases at Cole School in Boxford - 36 cases total from Jan 6 through Mar 6 - all mild symptoms, no severe or hospitalized cases. 12 of 23 classrooms has cases, predominantly in "multiage" classroom (grade 1/2)

Worked with school nurse, principal, superintendent and facilities director. Classroom notifications were sent for each case and a general notification was sent out by the principal to the school community on 2/10/23 to inform of an uptick in cases in the school community. State epi was notified of the cluster activity and monitored case activity. Enhanced cleaning was performed at school. Reviewed cleaning protocol, disinfectant choice, contact time etc with facilities director.

Per State Epi - "There is a nationwide increase of GAS (both invasive and non-invasive), so it is not surprising to see this. However, prompt treatment of cases, good hand hygiene and disinfection of shared surfaces should decrease the likelihood of transmission."

More cases coming through at other elementary schools in Topsfield.

Norovirus:

Trending upwards Nationally and in Northeast according to CDC Cases up 17% in March per CDC "Stomach flu" - Very contagious, spreads easily Hand sanitizer is not effective for norovirus, good handwashing is key! Spreads from:

- Having direct contact with an infected person

H5N1 Update Avian flu / Bird Flu:

What's up with egg prices? Some people have even experienced pasta & chicken rationing or shortages recently. (Dozen eggs at Market Basket is \$3.99, but many reports cite much higher costs) Experts estimate that 58 million birds have been affected in the U.S. alone since 2021.

Major production & supply chain issues due to quarantine, cleaning and culling of birds when cases occur. Avian flu / Bird Flu is not a new virus, the virus has come and gone for many years, typically carried by migratory birds and spreads to domestic birds, two types HPAI and LPAI, "high path" and "low path". Now is developing sub-strains and infecting mammals (foxes, bears, mink, whales, and seals) avian flu typically does not last this long in the bird population.

Recently in fall 2022, local cases of H5N1 in Danvers at Putnam Reservoir caused Topsfield Fair to close the Poultry exhibit (testing came back as low path H5N1 but had to close due to timing and quarantine measures). Anytime a virus enters the avian or swine population, there is a concern for "viral reassignment" and an epidemic or pandemic can occur like what was seen in 2009-2010, or more recently with COVID. This situation is not of great concern at this time but will continue to be monitored.

To date, approximately 10 humans have been infected worldwide with H5N1 (1 case in the US who had very mild symptoms and was a farm worker).

Collaboration from Public Health would be good use for opioid fund as TTC Grant fund for Mental Health First Aid is running out

Background on Youth Mental Health First Aid (YMHFA) offered by TTC:

From Meredith Shaw at TTC "We've run this program the past 5 years semi-annually, and with 2 trainers the capacity is 30. We had an agreement with Northshore Education Consortium to provide the training for up to 30 people for \$1200, and we've in the past covered the cost of participant manuals at \$20 per manual. Here's a blog post written by one of the trainers that outlines the program pretty well."

Approx Cost for current training (twice a year) \$3600 annually for training for 60 people.

Behavioral Health Helpline:

Great progress from MA, puts all info from the state such as 211, 988, B-SAS, Substance abuse hotline, into 1 place regardless of age, insurance, and need. One phone number is available now!

Began in 2019 under Gov Baker. Fully funder for the next 5 years. Since its launch in January, with no official marketing yet, the helpline has fielded over 5,000 calls. Goal is to stream line resources and reduce burden on ED's while getting people the help they need and will actually follow through with.



Informational materials are starting to come in that I ordered from DPH clearinghouse, I will be distributing them throughout Tri-Town - Police, Fire, Library, COA, schools.

TTU has met with the area outreach coordinator, Gail Cavanaugh-McAuliff, and will be promoting it as a resource for parents and students as well as staff. Dr Morrison will review info with principals and school committee members.

DESE is announcing the new platform on commissioners' weekly update as well.

Will see more advertising for the platform in April.

Highlights from 2021 CDC Youth Risk Behavior Survey Data Summary & Trends Report The report, which surveyed over 17,000 high school students, found that teen girls and LGBTQ+ teens are suffering unprecedented levels of suicidal thoughts, sexual violence, and substance abuse.

- Kids are not alright, kids are in crisis
- All students mental health got worse
- 3 in 5 teen girls reports sadness
- 42% of high school students, experienced depression
- symptoms in last year
- 29% reported mental health was poor in last month
- 10% attempted suicide in last year
- 14% of girls reported they were physically forced
- to have sex
- 25% LGBTQ were bullied, did not go to school, attempted
- suicide

What are current and future needs?

There are key guiding principles, strategies and toolkits in place on how to guide spending.

Principles for the Use of Funds From the Opioid Litigation (From Johns Hopkins School of Public Health)

1.

Spend money to save lives. Given the economic downturn, many states and localities will be tempted to use the dollars to fill holes in their budgets rather than expand needed programs. Jurisdictions should use the funds to supplement rather than replace existing spending.

2.

Use evidence to guide spending. At this point in the overdose epidemic, researchers and clinicians have built a substantial body of evidence demonstrating what works and what does not. States and localities should use this information to make funding decisions.

Invest in youth prevention. States and localities should support children, youth, and families by making long-term investments in effective programs and strategies for community change.
4.

Focus on racial equity. States and localities should direct significant funds to communities affected by years of discriminatory policies and now experiencing substantial increases in overdoses.

5.

Develop a fair and transparent process for deciding where to spend the funding. This process should be guided by public health leaders with the active engagement of people and families with lived experience, clinicians, as well as other key groups.

Note to Readers: As previously published, Table 1 contains counts of opioid-related overdose deaths in the city/town of residence for the decedents among MA residents. Table 2 contains counts of opioid-related overdose deaths in the city/town of the death occurrence. The counts in Table 2 are different from Table 1 because they include counts based on location of death versus location of the decedent's residence (Table 1). Massachusetts residents who died in Massachusetts are included in both tables. Massachusetts residents who died outside of Massachusetts are included in the "Death Occurrence" table (Table 2) as "Outside of Massachusetts". Non-Massachusetts residents who died in Massachusetts are not included in the "Residence" table (Table 1).

Table 1. Number of confirmed opioid-related overdose deaths for all intents by city/town of residence for the decedent, among MA residents, 2015-2021. From 2020 to 2021, additional cases are still being confirmed by the Office of the Chief Medical Examiner. This report will be updated quarterly and all new confirmed cases will be included in the table below with previously confirmed cases.


Public Health Excellence (PHE) Grant Update:
