#### **New Business**

#### <u>Facility</u>

Laura gave a rundown on the newly installed generator by Systems Electrical. The system is operating and is working well. Decibels produced by the generator and condenser have been measured to record the noise level. (Tuesday at 10 a.m., 86 dB, 72 dB on the sidewalk).

#### Programs and Collection and Other

Attendance at some programs was not as high as anticipated, but they were successful.

Since the DVD collection has been revamped, there has been no more stealing. The downside is that it requires more effort by the librarians to file the discs as they are returned.

Circulation is holding its own even though Library attendance is down slightly, possibly due to the weather this winter.

Coloring books and crayons are available in the periodical room for patron's enjoyment. Information is available on the Library website.

#### **Budget**

\$728.00 was returned to the Town from the Library budget.

The MVLC dues were \$19K for the operating budget, \$10K of the amount came from Gould A. The Gould Fund is the only fund to be used this year. There will be no use of small funds.

## **Former Business**

Library Hours will be discussed at the September meeting, along with an update of the Eskimo Art collection.

The Friends of the Library have been notified that we are trying to help increase their Board. Audrey informed the Trustees that she had made contact with the Council on Aging and Friends President Beth Aylmer regarding a notice to be placed in next month's COA newsletter.
