• Director's Report

- 1) Curbside service is doing well.
- 2) Meeting Room has become quarantine area. Consideration is being given to having appointments for browsing and computer use
- Cleaning of library has been less than optimal. Town is asking for bid for new cleaning service which will include the library and will hopefully result in improvement.
- 4) There is a problem on the second floor with HVAC pipes leaking which has caused problems with ceiling discoloration on the first floor. Town facilities manager will review but initial estimate is \$2600. As insurance deductible is \$2500, payment will have to come from library accounts.

Former Business

Library re-opening plans – Reopening will be a slow process. There is consideration to switching to digital magazine and newspapers both for cost and feasibility.

Friends of the Library – There will be no meeting this summer.

Small Trusts – Nothing to report.

FY2021 Budget Update – There is a town spending freeze and any spending needs to be approved by Town Administrator.

Capital Plan Update – Nothing to report.

Audrey Iarocci Memorial update – Nothing to report. K. Scott will continue to to discuss with J. Kmetz as to plan.

Gould Trust Fund update – Trust Commissioners will be invited to September meeting. Art Committee – Nothing to report.

Music Committee – The "Fab Four" are still scheduled to be on the Common on August 9th. Wendy Hansbury, Health Agent has been involved in discussions. There has to be social distancing of both band and audience which may be a problem. There is a prior concert planned for the week before and the Town Administrator will be making a final decision in the near future as to whether these events can be held as scheduled.
