I. Call to Order 7:30 P.M.

This will be the last meeting of the Cable TV Advisory Committee which was formed on September 9, 2019 "To assist the Town in the re-licensing of Verizon and Comcast franchise agreements. The Committee will be dissolved upon completion of the franchise renewal process."

The Comcast Cable TV License was approved by the Select Board on September 1, 2021 and the Verizon License was approved on 4/4/2022.

II. Approve Minutes of 12/16. (No meetings were held in January, February or March while the Verizon contract was being negotiated, due to the lack of information available from Verizon.)

III. Old Business:

- Review a Comparison of the Comcast and the Verizon approved Licenses.
- Review a Revenue Report of funds received from the 2 companies from 2018 to 2021 (actual) with a projection to the year 2027.

IV. New Business:

- Discuss what needs to be edited on the Town website, now that the Cable TV Advisory Committee has been dissolved.
- Discuss Implementation Issues.
 - The introduction of second high- definition video channels.
 - The introduction of a Comcast Senior Citizen Discount.
 - The installation of prior purchased video cameras in the 2nd floor auditorium.
 - \circ The purchase of audio / video equipment for the 2nd floor auditorium (from available funds?)
- Discuss the need to update the Town website relating to Local Access Cable TV. These changes would correct outdated information and begin to address the issues that were found from the Public Opinion Survey, relating to low awareness and limited use of local access programming.
