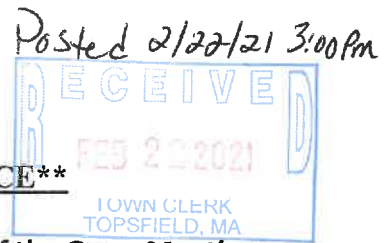


Topsfield Conservation Commission
