I. CALL TO ORDER

GOVERNOR'S ORDER

Jenn announced that, due to the COVID-19 State of Emergency announced by Governor Baker, this meeting would be conducted as a Virtual Meeting via ZOOM and as such, participation was remote. She then read the following:

III. SAC UPDATES

1. Earth Day/Town Clean-up 4/30

- a. Janelle- update-will be at town hall from 9-11 giving out plastic bags and tickets to go to Zumi's for a snack. There is a SignUp Genius to sign up
- b. Jenn-will be updating a sign frame to say something about town clean-up day to take pics and post on social media, solar bench may be up
- c. Kevin-solar bench will be up end of week/month, they need to have a tutorial before it is up

d. Zillie- asked if should circle back from elementary school about having students come and volunteer and Zumi's bakery is going to supply cookies for kids and going to look into allergy friendly options

2. Plastic bag ban compliance

a. Jenn-Kevin was going to follow up with Lelias: will follow up with Kevin

3. Green Future Act

- a. Jenn-members should have received Green Future Act and question is whether or not to bring the resolution to select board for consideration
- b. Tom- walked through document-reducing emissions goals by timelines
 - i. A bond program for states to raise revenue to hit goals
 - ii. Offering cash dividends for residents, and state to help residents help hit goals
 - iii. Pitched as a tool in the tool box and decide what tools to use and which will be added to the bills and by supporting at a town level helps move the ball forward in climate change efforts and tools they would be using
 - iv. Town of Salem has passed and many others are supporting
 - v. Cites this is a resolution and reiterates fossil fuels contributes to climate change, and if we support MA efforts it trickles down to our level and the funding needed to get there. Increasing carbon producing fees
 - vi. Next Step- transportation committees voting in May which we may or may not be in time for but it could be delay and may be able to get in time for that
 - Jenn- asks Marshall's thoughts about going next step to present to Select Board
 - Marshall- we should take a vote to support and someone from this board would need to be at the meeting to present this. Marshall offers insight on another presentation that was brought to the board was not approved because of money and support needed. But we may be in a better position
 - Andrew motions to have the Green Future Act brought before Town Select Board
 - Phil- seconds

c. All members vote to support resolution

 Tom offers to attend Select Board meeting to introduce the resolution.

4. Elementary Solar Project

- a. Jenn- will share in Brad's absence the update: Brad has attempted to reach out to contacts about presenting more thoroughly but has not been able to get that meeting scheduled as of yet. When he does we will have an ad hoc meeting for that. Andrew will bring to school committee and Marshall to select board
- b. Andrew- Elementary School Committee receptive but there may be some logistical hurdles to get over: going out to bid, the materials needing to be drilled into roof...etc. Provided that all of the logistics being handled he feels we would have support of school committee

c. Marshall- has not yet been able to present to the select board but feels that the nature of the board there will be many questions but feels they will be open to this discussion

5. Other items

- a. Tom- was going to look into noise rules- he looked at Topsfield and State of MA- Topsfield has some ordinance but nothing specifically towards gas powered equipment. State of MA has ordinances more general and even with that it seemed to be high threshold for an issue-bottom line current leaf blowing are well within the law
 - Confirmed that Lexington, Cambridge has ordinances in place that we can look into further for towns that have something like this in place
 - ii. Phil-are we looking more into noise pollution or the use of gas powered
 - iii. Jenn- I think we are interested in the noise ordinances are and perhaps encourage people to choose equipment that are more environmentally friendly

 - Phil-towns offering rain barrels at a discount
 - Julie-City of Chelsea is offering a program and Jenn asked if could share email
 - Zillie-remembers Topsfield offered something in the past

 - Zillie-Maybe educate Landscapers on promoting more native plant options
