## **Essex County Regional Communications Center:**

• **Draft Inter-Municipal Agreement:** Initial discussion of first draft proposal for a new Interagency Regional Agreement beginning July 1, 2019 for Fiscal Year 2020. Official written feedback sent December 14, 2018.

## **Topsfield Downtown/Village Center Initiatives:**

- Business Outreach: Select Persons Spencer & Bermudez visited businesses during the Holiday on the Common event Saturday, December 1<sup>st</sup>.
- Parking Management Grant Application: A grant application for \$15K submitted to the State's Downtown Initiative Grant Program to perform a Downtown Parking Management Plan. Awaiting notification a decision.
- MAPC Initiatives: Topsfield representatives attended the Metropolitan Area Planning Association ("MAPC") Meeting on 11/15/18. Proposal to MAPA to develop a Downtown Village Master Plan initiative was sent.

#### **Public Hall:**

 Next Steps: BOS Approval of all policies and documents in January. All materials to be posted on the Town's website by 2019. Marketing campaign to be developed.

#### **Collective Bargaining:**

- Reserve Police Officers: Two meetings held; Next meeting is being scheduled.
- Topsfield Teachers: Initial Ground Rules Meeting Session scheduled for Dec. 4<sup>th</sup>, 2018.

#### **Payroll Conversion Project**

- Status: Worked with Treasurer to implement payroll conversion project.
- Objectives: Convert from weekly to bi-weekly pay for all Town employees; Convert from Thursday-Wednesday to Sunday-Saturday pay periods; Increase efficiencies for payroll administration; Reduce redundancies in procedures; Improve payroll process for Department Heads, payroll staff and employees.
- Goal: Target date for conversion is February 28, 2019.

#### **Town-Wide Signage:**

• Status: Letter drafted for Business outreach mailing; Package assembled for business mailing (ie. By-Law & signage regs).

- Overview: 28 residential homeownership units (7 affordable) 8.2 acres at 57 Perkins Row.
