Budget:

The Committee's goal was to commit to the funding of projects which would utilize the remaining \$40,201.71 of the Town Hall Project. As detailed at previous meetings this amount needs to be drawn down to zero as it was borrowed funding and recommended by the Treasurer/Collector, Barbara Michalowski to do so. Donna Rich reviewed the items with amounts from proposals submitted to the committee. In addition, other potential funding sources, the FY18STM/A10 PEG TH and Donations were reviewed and discussed as to the best use of available funds.

Peter Bryson made a motion to approve the funding for the following projects: Acoustical Panels for the Public Hall, Hamilton Associates of Lowell MA for \$31,600, Replacement of the Historical Front Door, Miles Restorations of Boxford MA for \$19,000, with a \$1,000 owners contingency, the addition of the extension to the Board of Selectmen Meeting Room desk, WB Mason for \$2,800 and electrical work for the clock tower, Bass River Services of Beverly MA for \$1,435.64, in addition to offset the acoustical panels \$15,633.93 would be funded through the FY18STM/A10 PEG TH, seconded by Ben Nutter; so voted: 5-0.
