Communication of the event to the residents was discussed and it was suggested that the architects could assist in the design and the committee would be responsible for the message. Member Liz Mulholland volunteered to spearhead this project using a post card approach with flyers to be displayed at downtown merchants.

<u>Town Land</u>: Member Mark Lyons commented that next steps to the Donohoe Survey Inc should be explored with Kopelman & Paige PC. Donna Rich was asked to enable that conversation to begin; Mark Lyons offered to speak directly with the appropriate attorney.

At 10:04 Member Josh Rownd made a motion to adjourn, seconded by Member Mark Lyons; so voted: 5-0.
