



By his letter dated September 9, 2020, Glen Clohecy, Building Inspector and the Zoning Enforcement Officer, concluded that Connemara Farm may conduct wedding and other events as an Agritourism activity as a matter of right. The use by Connemara Farm to conduct weddings other events comes within the definition of Conference and Event Facilities pursuant to use Regulations, Article III 1.22. It is located in an Outlying Residential and Agricultural District. The owners of Connemara Farm are required to obtain a Special Permit for such use pursuant to Use Regulations Article III – 2.17 because such use is not within the term Agritourism; and therefore, the use by Connemara Farm to conduct weddings and other events is not a use as a matter of right.

Mr. Clohecy concluded that the weddings and events as conducted by Connemara Farm Agritourism within the definition of Farming and Aquaculture and cites <u>General Laws</u>, Chapter 40A § 3. That statute does not contain a definition of farming and agricultural; although, <u>General Laws</u>, Chapter 128 § 1A defines farming and agricultural to

include farming in all of its branches and the cultivation and tillage of the soil, dairying, the production, cultivation, growing and harvesting of any agricultural, aquacultural, floricultural or horticultural commodities. . .

That statute, nor the notes of decisions under it, do not mention weddings and events. The holding in <u>Valley Green Grow, Inc. v. Town of Charlton</u>, 173 N.E.3d 395, 408, 99 Mass.App.Ct. 670, 685 (Mass.App.Ct., 2021) requires that the use be "directly related to the farming operations of the owner." The weddings and events conducted by Connemara Farm are not directly related to its farming operations.

The term Agritourism has not been adopted as a law in Massachusetts. Agritourism is the subject of a pending bill in the Senate #2643, which does not provide that weddings and such other events are Agritourism activities. It defines Agritourism as "an agriculturally related . . . activity. . ." It provides that the Agritourism activity must come from product grown on the farm or another qualifying Massachusetts farm, a minimum of 35% of which must be produced at the farm at which the Agritourism activity takes place. It does not appear that the wedding and other event activities and the production and use of farm products of Connemara Farm meet this criteria. If so, Connemara Farm must produce financial information to show that it is within this threshold.

The Massachusetts Legislature formed the Massachusetts Agritourism Study Commission, which issued a Final Report on March 16, 2022. Although weddings are potentially in Agritourism activity, it indicated that the conduct of such activities should be subject to thresholds and the use of the local farm product as provided in the pending bill.

In its unsigned support letter, Connemara Farm has argued that such events "enhance the marketing of the farm's product . . ." It does not appear that such is the case, but rather, the farm products enhance the business of Connemara Farm as an event facility.

Connemara Farm continues the use of amplified sound and the sounds of the many guests attending their events are disturbing to the neighbors.

Wherefore request is made that Building Inspector, as the Zoning Enforcement Official, enforce the Zoning Bylaw and order the owners of Connemara Farm to cease and desist its operations until such time as a Special Permit is granted for their operations of its Conference and Event Facility.

At the request of Connemara House Farm LLC, the owner and operator of Connemara House Farm, 252 Rowley Bridge Road I have conducted an inspection and reviewed relevant documents relating to the operation of Connemara House Farm.

As a result of my review, I have concluded that according to the plain language of the Zoning Act (40A, §3), the statutory definition of "Farming and Agriculture", the Town of Topsfield Zoning and General By-Laws and the Massachusetts Department of Agricultural Resources guidance instructions, weddings, celebratory assemblies and social and corporate events venue to enhance the marking of the farm's product may be conducted as an Agritourism activity as a matter of right. Connemara House Farm may conduct Agritourism as promoted by both the Federal and State Agriculture Departments and allow weddings, celebratory assemblies and social and corporate events to be conducted on the farm property.
